Comprehensive Vehicle Population

The total number of vehicles included in this campaign is 1277.

Effected Population Assessment

100% of the vehicles identified above may contain defective equipment.

Defect Description

On certain Newmar Class A motorhomes built on Freightliner and Spartan chassis, a problem with the uppernut/bolt connecting the steering column not being torqued down correctly which could result in the nut coming loose and falling off the bolt. This could result in the loss of steering control and increase the risk of a crash.

Principle Event Chronology

Newmar Corporation is reporting this recall following an initial warranty claim on 03/09/22 that initiated a safety review meeting of the issue. It was determined at the safety review meeting on 3/10/22 a recall should be issued with the initial 58 units noted in this recall.

After initial filing of recall, Newmar manufacturing team reviewed the assembly plant process and determined that out of an abundance of caution an additional population of affected vehicles should be added.

Newmar Corporation is not aware of any property damage, injury, or death, in vehicles manufactured by Newmar Corporation, attributed directly or indirectly to this defect.

At the time of this letter Newmar Corporation has received one warranty claim for this recall.

Defect Remedy Program

Newmar Corporation will be conducting this recall in its entirety. Units identified as having a possible steering column issue will have the upper and lower nut/bolt checked for the correct torque and if needed tightened to the correct torque. All repairs will be at no cost to customer.

If the customer has had the repair performed before receiving this letter, they may be eligible to receive reimbursement for the cost of obtaining a pre-notification remedy. For additional information, contact Newmar Corporation at:
