Issue: In certain vehicles, the long fuel injectors may have been assembled without filter element. An injector built without filter element may leak, and fuel may enter into the engine compartment. Leaking fuel, in the presence of an ignition source, may increase the risk of a fire.

Precautions: If the recall condition is present in the vehicle, customers may recognize a fuel odor or notice fuel leakage. Additionally, the check engine light may illuminate. If this happens, customers are advised to contact an authorized Volkswagen dealer without delay to have the vehicle inspected/repaired.

- REPAIR AVAILABLE – July 14, 2022 / Replace the long fuel injectors (cylinders 1, 3, 5)
 - See ELSA/ServiceNet for complete repair & claiming instructions
 - Check both the daily Campaign Open Inventory report and OMD for affected vehicles in inventory. Verify OPEN status in ELSA on the day of repair.
 - Repair every affected inventory vehicle before delivery to consumers.

Parts Department: There will be no parts allocation. Parts will be managed by Free Order.

IMPORTANT REMINDER: VEHICLES AFFECTED BY SAFETY & COMPLIANCE RECALLS

New Vehicles in Dealer Inventory: It is a violation of federal law for a dealer to deliver a new motor vehicle or any new or used item of motor vehicle equipment (including a tire) covered by this notification under a sale or lease until the defect or noncompliance is remedied. By law, dealers must correct, prior to delivery for sale or lease, any vehicle that fails to comply with an applicable Federal Motor Vehicle Safety Standard or that contains a defect relating to motor vehicle safety.

Pre-Owned Vehicles in Dealer Inventory: Dealers should not deliver any pre-owned vehicles in their inventory which are involved in a safety or compliance recall until the defect has been remedied.
