This work will take about three hours to complete and will be performed for you free of charge. 





Section A - Check for Previous Repair

- Confirm the Campaign/Action is open <arrow 1>. If the status is closed, no further work is required.
- Note the Applicable Criteria ID <arrow 2> for use in determining the correct work to be done and corresponding parts associated.






Remove air duct:


- Remove the bolts <arrows>.
- Pivot out the air duct <1> from the lock carrier and remove upward.



Disconnect ignition coils:

• Unclip the cover strip off the ignition wiring harness in direction of <arrows> and move it forward from the retaining tabs <A>.






- Place the -T10118- on the release button <arrow> and carefully pull all connectors off the ignition coils.
- Move the wiring harness to the side.


Remove air filter housing:

- Remove the connector <1> for the Mass Airflow Sensor -G70-.
- Open the hose clamp <2> and remove the air duct hose.
- Remove the air filter housing <3> upward from the rubber bushing.



Remove air hose and disconnect connectors:

• Disconnect the connectors <1> and disconnect the connecting hose <3> for the crankcase ventilation from the cylinder head cover.




Disconnect vacuum lines and remove intake manifold upper section bolts:


- Remove the lines <arrows> from the intake manifold upper section.
- Remove the mounting bolt for the rear intake manifold support <1>.
- Remove the bolts from the front intake manifold support <2>.

Disconnect Vacuum Actuator for Change-Over Valve:

• Disconnect vacuum hose <circle> from Vacuum Actuator for Change-Over Valve <4>.

Disconnect oil dipstick tube from intake manifold upper section:

- Remove bolt <circle> for the oil dipstick tube <1> using a bit ratchet <A>.
- Position tube out of the way in the direction of <arrow>.

Remove intake manifold upper section:

- Remove bolts <1> through <5> and remove intake manifold upper section.
- Push the oil dipstick tube to the side while removing the intake manifold upper section.



Ensure the Vacuum Actuator for Change-Over Valve is not damaged when lifting off the intake manifold upper section.


Insert rags into lower intake manifold openings:

• Place clean, lint free rags into the lower intake manifold openings.



Remove lifting hook:


- Remove bolts <arrows>.
- Free up vacuum line <circle>.
- Remove lifting hook <A>.



Disconnect battery:

- Turn off the ignition and all electrical equipment.
- Move the ignition key outside of the vehicle to prevent the ignition from switching on unintentionally.
- Open the cover <1> over the battery ground terminal post.
- Loosen the nut <3> several turns.
- Remove the battery terminal clamp <2> off the ground cable from the battery terminal.

The fuel system is under pressure. Risk of injury from fuel spraying out.

Wear protective eyewear.




Reduce the pressure: place clean cloths around the connection point and carefully open the connection point.

• Remove the clamps and remove low pressure fuel hose <A>.

Remove high pressure pipe:

• Counter-hold union nuts with a wrench and remove high pressure fuel pipe <1>.






Loosen coolant pipe:

• Remove bolts <1> and <2> for coolant pipe <3>.


Remove high pressure fuel pump:

- Disconnect connector <A>.
- Remove bolts <arrows> and remove the high pressure pump from the engine.
- Remove the cam follower and carefully set aside.




Remove connecting fuel pipe between fuel rails:

- Counter-hold union nuts, loosen connections <1> and <2>.
- Remove pipe <A>.



Loosen lower intake manifold bolts:

• Loosen the bolts <arrows> for the intake manifold lower section, but do not unscrew them completely.









Remove fuel rail and set to the side:

- Remove bolts <arrows>.
- Carefully remove fuel rail <1> off of fuel injectors.

The fuel hose <2> stays attached to the fuel rail.

- When removing the bolts for the fuel rail, they may come into contact with the intake manifold lower section <arrows>.
- Carefully pull the intake manifold lower section forward to allow the bolts to be fully removed from the fuel rail.
- Ensure the intake manifold lower section is not damaged in the areas that may make contact with the bolts or the tools used to remove the bolts.
- Set the fuel rail aside with the return hose still attached.
- Cover the openings to prevent fuel from leaking onto the engine and to prevent dirt from entering the openings.







Remove fuel injectors:


• Push the O-ring upward as shown and remove it from the fuel injector.

 Install the Injector/Combustion Chamber Seal
 Expansion Set Puller -T10133/15- into the groove <arrow> on the fuel injector.





• Loosen the fuel injector from its seating with careful strokes.

- Pull out the fuel injector <1> far enough that it can be turned by approximately 90° <arrow>.
- Disconnect the connector <2>.
- Remove the fuel injector <1>.

Clean each fuel injector hole in the cylinder head:

• Clean the fuel injector holes in the cylinder head thoroughly with the Injector/Combustion Chamber Seal Tool Set - Brush -T10133/4-.





Install new injectors:




- Do not oil or grease the combustion chamber sealing ring (Teflon) on the fuel injector.
- Do not pull the fuel injectors into their seats over the fuel rail threaded connection. This will damage the spring element.
- Coat the O-ring between the fuel injector and the fuel rail lightly with clean engine oil.
- Make sure that the fuel injectors are installed securely in the cylinder head.
- Press the fuel injector by hand all the way into cylinder head. Do not press on the spring element at the same time.
- Check the spring elements. They must not be pressed flat <arrows>.

Reinstall fuel rail:

- Installation is the reverse order of removal.
- Coat the O-ring between the fuel injector and the fuel rail lightly with clean engine oil.
- Replace bolts.
- Torque new bolts <arrows> to 30 Nm + 90°.




Tighten intake manifold lower section bolts:

 Torque intake manifold lower section bolts to 8 Nm

Reinstall connecting fuel pipe between fuel rails:

- Installation is the reverse order of removal.
- Counter-hold union nuts, tighten connections <1> and <2 > as follows.
 - o Tighten by hand.
 - Torque connections to 28 Nm.




Reinstall high pressure fuel pump <1>:

- Installation is the reverse order of removal.
- Coat the cam follower <2> with clean engine oil and install into the cylinder head.
- Replace O-ring <3>.
- Replace bolts <4>.
- Torque new bolts <4> alternately to 10 Nm.

- Install bolts <1> through <5> as follows:
 - By hand, working from the inside outwards.
 - Torque to 10 Nm. working from the inside outwards.






- Reconnect ignition coils.
- Reinstall cover in the reverse order of removal.
- Reinstall air duct cover in the reverse order of removal and torque bolts to 2.5 Nm.

Reconnect the battery:

- Disconnect the connector <2> from the Battery Monitoring Control Module -J367- <3>.
- Install the battery ground cable terminal clamp by hand on the battery negative terminal "–".
