### INTERIM SAFETY RECALL NOTICE FOR YOUR VEHICLE

#### A recall repair is not yet available

This notice is sent to you in accordance with the *National Traffic and Motor Vehicle Safety Act*. Volkswagen has decided that a defect, which relates to motor vehicle safety, exists in certain 2021-2022 model year Volkswagen vehicles. Our records show that you are the owner of a vehicle affected by this action.

**About this recall:**

In certain vehicles, the long fuel injectors may have been assembled without a filter element. An injector built without a filter element may leak, and fuel may enter into the engine compartment. Leaking fuel, in the presence of an ignition source, may increase the risk of a fire.

**A recall repair is not yet available.**

We will send another letter as soon as the recall work can be completed on your vehicle.

**What you can do now:**

Please do not contact your dealer about this recall unless you believe your vehicle has the condition described in this letter.

If the recall condition is present in the vehicle, customers may recognize a fuel odor or notice fuel leakage. Additionally, the check engine light may illuminate. If this happens, customers are advised to contact an authorized Volkswagen dealer without delay to have the vehicle inspected/repaired.

Your safety and that of your passengers is our highest priority, and we are working to make a recall repair available as soon as possible. We apologize for any inconvenience this letter may cause.
