Dear Tiny Idahomes Customer:

PLEASE RESPOND IMMEDIATELY RECALL CAMPAIGN 22E-003

Part 573 Safety Recall

This letter is sent to you in accordance with the requirements of the National Traffic and Motor Vehicle Safety Act.

Tiny Idahomes LLC has decided that a defect which relates to motor vehicle safety exists on some of our 2021-2022 Rugged Mountain Custom RV Travel Trailers, manufactured between 08/06/2021-10/25/2021. This recall is the result of information provided to us by Pacific Trailer Products, Inc. Dexter, and Fusion Metal Works. Tiny Idahomes records indicate that your Tiny House RV may have one of the effected couplers.

THE PROBLEM

Tiny Idahomes was notified that a bin of tack welded (incomplete weld) CA-5400 couplers were mixed into other finished products in July 2021 at the Pacific Trailer Factory. These couplers may have been installed on our trailers between 8/6/2021-10/25/2021. All couplers shipped are identified with the tracking numbers called QC codes.

Affected Units

The potentially affected couplers have the following part numbers:

CA-5400-0

CA-5400-B

This recall **requires immediate service** and continuing use could pose a potential safety hazard without following the instructions below.

How do I know if my trailer has one of these couplers being recalled?

- 1) A visual inspection of the coupler attached to your trailer hitch will verify if the coupler has spot welds or an incomplete weld.
- 2) See attached pictures for an example of what to look for.

For any trailer that has the recalled coupler installed, you must follow these two bulletized directives.

- Inspect the coupler, looking for an incomplete weld.
- Do not attempt to pull the trailer until the coupler has been repaired or replaced if an incomplete weld is found.

AFTER VERIFYING THAT YOUR TRAILER HAS A RECALLED COUPLER INSTALLED, YOU NEED TO

IMPORTANT

Please do not call anyone to have this repaired until you have contacted Dexter and they have given you instructions. Keep this letter for your records until the coupler has been repaired or replaced.

If you no longer own this RV trailer:

If you are no longer the owner of this RV trailer, Tiny Idahomes would greatly appreciate you furnishing us with the name and address of the new owner by calling 208-468-0576 so that we can send this notice to that new owner.




