Description of the Defect: The power steering pressure line in affected vehicles may be inadequately

connected to the brake Hydroboost unit, which may result in a leak or sudden

loss of power steering fluid.

FMVSS 1: NR FMVSS 2: NR

Description of the Safety Risk: Sudden loss of power steering fluid may result in a loss of power steering

assist, requiring increased steering effort, and loss of power brake assist, requiring increased force on the pedal to brake, potentially resulting in increased stopping distance. A sudden loss of power steering assist and

power brake assist increases the risk of a crash.

Description of the Cause: The fitting between the power steering pressure line and the brake Hydroboost

unit may not have been adequately connected during the assembly process.

Identification of Any Warning A power steering fluid leak may occur, resulting in steering fluid on the ground

that can Occur: underneath the vehicle. Some drivers report hearing an audible "pop" if the power steering pressure line fitting becomes disconnected while driving.
