system needs to be extended to protect the storage compartment from the heat of the exhaust system. Without the extended heat shield the compartment may

melt.

compartment may melt, increasing the risk of of a fire hazard.

Description of the Cause: The heat shield designed by Jayco is not large enough to protect the storage
