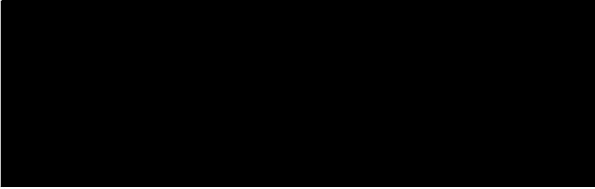

Dear Mercedes-Benz Owner:

This notice is sent to you in accordance with the requirements of the National Traffic and Motor Vehicle Safety Act.

Mercedes-Benz AG ("MBAG"), the manufacturer of Mercedes-Benz vehicles, has decided that a defect which relates to motor vehicle safety exists on certain Model Year ("MY") 2021 GLB-Class vehicles. Our records indicate that your vehicle is included in the affected population of vehicles.

What is the issue?



On certain MY 2021 GLB-Class vehicles, the level sensor linkage on the rear axle might not have been installed properly, which could affect the headlight leveling function. Subsequently, improperly leveled headlights may project a glare, which can impact other drivers and increase the risk of a crash.

What will your Mercedes-Benz Dealership do?



An authorized Mercedes-Benz dealer will check the level sensor linkage on the rear axle on the affected vehicles and rework, as necessary. **This service will be provided free of charge.** We are dedicated to always delivering the best customer experience, and respect for your time is a top priority. While the minimum repair time can be less than 1 hour, your dealer can provide you with a better estimate of the overall time for this service visit. As a matter of normal service process, an authorized Mercedes-Benz dealer will also check for other repair measures which might be applicable to your vehicle and this may increase the required working time.

Steps to take.



- Find your nearest authorized Mercedes-Benz dealership at mbusa.com/recall to schedule your recall repair.
- Please mention you are scheduling an appointment for Mercedes-Benz Recall Campaign **2022050011**
- You may be asked for your VIN, which for your convenience is located at the top of this letter.
- **Impacts from COVID-19:** Your health and safety remain our top priority. The Mercedes-Benz dealerships remaining open for recall repairs and service are closely following the guidelines set forth by the CDC. Vehicle pick-up and delivery may be available. Your preferred authorized Mercedes-Benz dealer can confirm availability
