Description of the Safety Risk: Under certain conditions, momentary text message board duplicating regulated lamp signals may cause confusion with the standard signals sent by
the lighting equipment required under FMVVSS 108, and may increase the risk of a crash.

2022-01 Other momentary text message board duplicating regulated lamp signals were discovered (Yield and Stop).
2022-02-14 Nova Bus Product Safety Working Group is informed of the potential non-compliance issue. Investigation opened.
2022-04-06 Nova Bus Product Safety Committee 1st evaluation of this potential regulatory non-compliance. 2022-05-04 Nova Bus Product Safety Committee 2nd evaluation and determines a regulatory noncompliance exits.
2022-05-05 Nova Bus issues a delivery stop for the affected vehicles.
2022-05-11 Nova Bus submits a vehicle recall report to NHTSA.
Nova Bus has not received any consumer complaint, field report, property damage claim, and neither notice or claim of injury or death associated with this regulatory noncompliance.

No compliance testing was performed related to this regulatory noncompliance due to the nature of the noncompliance. FMVSS 108 S6.2.1 regulatory interpretations were the main compliance activities.

## Description of Remedy :

Description of Remedy Program : Nova Bus will provide a service document to remove the momentary text message board duplicating regulated lamp signals and associated equipment. All cost associated with this corrective measure will be covered by Nova Bus. Pre-notification remedies will be addressed using the Nova Bus general reimbursement plan on file with NHTSA.

How Remedy Component Differs Not applicable. Momentary text message board duplicating regulated lamp from Recalled Component: signals will not be a system available on our vehicles anymore.
Identify How/When Recall Condition From 2022-05-05, momentary text message board duplicating regulated was Corrected in Production : lamp signals will not be a system on our vehicles sold anymore.
