

On, or near, February 25, 2022, an inquiry was submitted to engineering relating to tire placard information not matching the physical vehicle. (Specifically tire size) On March 16, tire placard information was submitted to Product Compliance however information relating to the vehicle was not. A formal investigation began. On March 30, 2022, potential errors with the certification label were discovered and confirmed to be incorrect. On April 13, a notice was sent to all Utilimaster branded sites to confirm labels contained the correct information that matches the vehicle. Confirmation from all sites but one confirmed labels were accurate. Shyft confirmed the subject population and on May 6, 2022 it determined 2 non-compliances to exist in the affected vehicles.
