On May 11, 2022 Keystone Coachworks Inc received notification from the Dometic Corporation and from Beth Wolfe the Safety Recall Specialist from NHTSA that the model PI8022, 2 Burner LP Cooktop that we purchase is involved in a recall. Barb Wagner, the Recall Supervisor from Dometic supplied Keystone Coachworks with a range of serial numbers of the affected units to determine if we had any units installed in our customers conversions.

#### **Description of Remedy :**

Description of Remedy Program :	Dometic Corporation is aggressively approaching all OEM's, Dealers, Retailers, and End Users with certified letters (for which they must sign), defining the product, models, population, and direction on action to be taken. The remedy will consist of 1) instructions to locate the cooktop serial number 2) Recall Response Card to be filled out and returned to receive the replacement unit. Dometic will reimburse the repair facility for their time related to replacing the defective unit with a new one.
How Remedy Component Differs from Recalled Component :	The serial number will distinguish the recall units from the replacement parts.
	We documented all the inventory we had on hand and have contacted Dometic Corporation for a call tag so that the defective units can be returned.
