Description of the Defect: The left door outside handle may not have been properly assembled. The safety

clip of the cable that unlatches the door when the outer handle is pulled may have not been properly positioned. As a result, over time, the cable could become loose and the left-side doors may not be able to be opened from

outside of the vehicle.

FMVSS 1: NR FMVSS 2: NR

Description of the Safety Risk: It might not be possible to open the unlocked door on the left side by using

the outside door handle, posing an entrapment risk. This failure could lead to the inability to operate the handle from outside of the vehicle with a safety

risk in case of emergency.

Description of the Cause: Due to a production deviation during the assembly of the component, the

Chronology:

On May 2022 during end of line quality checks Automobili Lamborghini S.p.A. identified a case where the safety clip at the end of opening Bowden cable, was not correctly rotated and engaged.

Automobili Lamborghini S.p.A. immediately launched an internal investigation to determine the scope of this topic and the root cause. In the course of the investigation it was determined that the deviation was traceable to human error during the specific step of the assembling process.

Results from the investigation revealed a risk that a number of vehicles produced between April 15th 2022 and May 17th 2022 may present the issue.

A plant campaign was launched to contain potentially affected vehicles. However, some potentially affected vehicles had already been released to the markets.

On June 10th 2022 the matter was presented at the Product Safety Committee which determined that a potential safety risk cannot be ruled out and decided to conduct a voluntary safety recall.

Lamborghini is not aware of any warranty claims or customer claims due to this issue.

Description of Remedy:

Description of Remedy Program : Automobili Lamborghini S.p.A. will notify all owners of affected vehicles

and will instruct them to arrange for an appointment with an authorized Lamborghini dealer. Dealers will check the safety clip positioning and

correct it if necessary, free of charge.

How Remedy Component Differs The door handles have guaranteed correct engagement of the bowden
