Dear «OWNER»:

This notice is sent to you in accordance with the requirements of the National Traffic and Motor Vehicle Safety Act. Cruiser RV (Cruiser) has decided that that certain 2022 Shadow Cruiser Travel Trailers do not conform to 49 CFR Part 567 – Certification and Federal Motor Vehicle Safety Standard. On the vehicles subject to this recall, the Federal Certification Label may contain incorrect Gross Axle Weight Rating (GAWR). We apologize for any inconvenience this action may cause you, however your safety and continued satisfaction are of the utmost importance to us.

***Reason for  
this recall***

It has been decided that certain 2022 Cruiser Shadow Cruiser travel trailers subject to this recall campaign may have a Federal Certification label on these vehicles that do not have the correct Gross Axle Weight Rating (GAWR) listed on the label. If the GAWR is not listed properly, the operator would not know the trailer's correct weight limit and may overload the vehicle, increasing the risk of a crash.

***What we  
will do***

Cruiser will have an authorized dealer or repair center replace the Federal Certification Label. This will be corrected at no expense to you, the owner. This recall should take 10-12 minutes to complete. We have enclosed the replacement label so that it can be replaced quickly.

***What we need  
you to do***

At your earliest convenience, please contact your local dealer to set up an appointment to have this corrected immediately, this service will be performed free of charge.

You will need the following information for the phone call:

- VIN of your travel trailer
- Name, Address, and Phone Number
