This notice is sent to you in accordance with the requirements of the National Traffic and Motor Vehicle Safety Act. KZRV has decided that a defect which relates to motor vehicle safety exists in certain 2022 & 2023 Connect, Confluence, Durango, Durango Gold, Sonic, Sportsmen, Sportsmen Classic, Sportsmen Sportster, SportTrek, Spree Escape, and Venom models. As a result, KZRV is conducting a safety recall. We apologize for any inconvenience this action may cause you; however, your safety and continued satisfaction are of the utmost importance to us.

**Reason for  
this recall**

The vehicles subject to this recall were built with a Lippert awning that has a bad plastic weld. As a result, the awning could rip which will result in the awning becoming detached from the coach resulting in personal injury, property damage, or a crash. This repair will be done at no cost to you.

**What we  
will do**

The remedy is to inspect the awning, repair if able, or replace if necessary. The repair should take between 10 minutes to 2 hours depending on the repairs needed to complete. This repair will be done at no cost to you.

**What we need  
you to do**

You should contact your selling dealer immediately to schedule a service appointment to have the defect repaired in your vehicle. If you had appropriate repairs completed prior to receipt of this recall notice, and if you incurred any direct cost in connection with obtaining such repair, you may be eligible to receive reimbursement from KZRV by contacting the **KZRV Warranty/Service Department**.
