Keystone RV Company has decided that a defect which relates to motor vehicle safety exists in certain model 2022 Aspen Trail, Carbon, Coleman, Colorado, Cougar, Hideout, Montana, Outback, Passport, Raptor, Retreat, Springdale, Sprinter, Voltage, Yukon, 2022-2023 Bullet, Fifth Wheels and Travel Trailers. As a result, Keystone RV is conducting a safety recall.

Repair Instructions & Claims Processing Update– As of November 17, 2022, Keystone RV is Administering this RECALL. Submit all claims and part orders on Key Express.

Reason for this recall

It has been decided that vehicles in the recall population were built with a certain Lippert Electric Retractable Awnings, up to 18 feet in length, that the heat-welded seam may separate. Under certain conditions during use or travel the welded seam on the fabric may separate, potentially allowing the awning to drop beyond normal operation leading to an increased risk of personal injury.
