INTERIM NOTICE

October 14, 2022

Dear Kia Telluride Vehicle Owner:

Kia has identified a defect in your vehicle which relates to motor vehicle safety.

This notice is sent to you in accordance with the requirements of the National Traffic and Motor Vehicle Safety Act. Kia America, Inc. has decided that a defect which relates to motor vehicle safety exists in certain 2020 MY Telluride vehicles equipped with a Genuine Kia 4-pin tow hitch harness accessory. The defect can cause a fire, increasing the risk of injury. Our records indicate that you own or lease one of the potentially affected vehicles.

This is an interim notice as we work on identifying the cause and developing a final remedy. In the meantime, Kia has developed an initial remedy to mitigate fire risk. We will send you another letter when a final remedy is available. The purpose of this letter is to keep you informed of Kia's recall implementation plan. <u>PLEASE SEE THE "WHAT SHOULD</u> YOU DO IN THE INTERIM" SECTION BELOW.

What Is The Problem?

A fire may occur in the area of the tow hitch harness module <u>while driving or while the vehicle is parked with the ignition off</u>. Debris and moisture contamination on the tow hitch harness module printed circuit board (PCB) may cause an electrical short circuit, increasing the risk of a fire. A fire increases the risk of injury.

Kia Will Install A New Fuse. This Initial Remedy Will Be Performed Free of Charge At No Cost To You.

Kia will install a new fuse with a different capacity, as an <u>initial remedy</u>, to mitigate fire risk. When the final remedy becomes available, Kia will send you a follow-up notice. The new fuse installation and the final remedy will be performed **free of charge at no cost to you.**

What Should You Do In The Interim?

- In the interest of the safety of your passengers, as well as your own safety, contact your authorized Kia dealer to schedule a service appointment to have the new fuse installed in your vehicle.
- Park your vehicle outdoors and away from other vehicles or structures until you have the new fuse installed.

What If You Are A Vehicle Lessor?

Federal regulation requires that any vehicle lessor receiving this recall notice must forward a copy of this notice to the lessee within ten days.

QR Code Use:

- A QR Code is a square, 2-dimensional barcode that can be read by mobile devices loaded with an appropriate barcode or **QR Code Reader App**. The app reads the barcode image and then launches/uploads the specific information the code contains, such as URLs, text, photos, videos.
- With a mobile device, download a QR Code Reader App. With many devices, you can do this through an app store or marketplace.

[•] Open the QR Code Reader App on your mobile device. The app will utilize your device's camera. Center the code in the camera viewing area. With some apps, the URL or other information will automatically load when the code is recognized. For others, you may have to snap or take a picture of the QR code.
