On August 9, 2022, production reported to the codes and standards team that we built units with the refrigerator LP Line concealed in the underbelly. August 10, 2022, Codes and standards team emailed the Jayco compliance team the incident with the affected units from our production records. On August 15, 2022, this incident was discussed at WIRC (Warranty & Incident Review Committee) and elevated to CPAC (Corrective and Preventative Action Committee). On August 17, 2022, this incident was discussed at CPAC and elevated to SSC (Safety Steering Committee). On August 25, 2022, SSC discussed this incident and voted to proceed with a recall. Jayco has received no warranty claims for this situation.
