Background:

Vermeer MV Solutions, Inc. has decided that a defect, which relates to motor vehicle safety, exists in certain model year 2011 – 2020 Vac-Tron AIR533SDT, AIR535SDT, AIR555SDT, AIR573SDT, AIR833SDT, AIR835SDT, AIR855SDT, AIR873SDT, and AIRSDT vacuum excavator trailers. Vermeer Corporation is administering this product safety campaign on behalf of Vermeer MV Solutions, Inc.

TRAILER FRAME FAILURE MAY OCCUR

Frame bending or distortion can develop in the trailer main frame which can result in loss of stability while towing.

DEATH OR SERIOUS INJURY POSSIBLE

When towing the vacuum excavator trailer on public roadways, **death or serious injury** may result due to the loss of control of the vacuum excavator trailer and towing vehicle. A frame failure may increase the risk of a crash. Property or equipment damage may also occur.

Solution:**IMMEDIATE MACHINE MODIFICATIONS REQUIRED**

VMV000028 has been created to provide the necessary parts and instructions to add a plate gusset to reinforce the trailer frame. **The kit must be installed as soon as possible.**

2. **Dealership orders kits** by calling 888-822-8766 (Florida). Each dealership should determine the quantity of kits to order initially depending upon the number of units that may be available for immediate upgrade. **Do not order more kits than needed for immediate installation.**
3. **Contact your affected customer(s)** to schedule a mutually acceptable time to upgrade their machine(s). **Note:** Letters will be sent to the customer(s) on or about **October 27, 2022**. *Also refer to Owner Notification section below.*

REIMBURSEMENT

Upon completion of each kit installation, a campaign warranty claim must be submitted to the warranty department for reimbursement of the cost of parts and labor to install the kit. Labor hours to install: 1.5 hours.

Travel will be paid up to \$200 (\$1 per mile with a \$200 max round trip) with copy of work order attached for retailed machines not in dealer inventory. If dealer

repairs more than one machine at same location on one trip, travel will only be paid on one of the model/VINs. **The dealer may not charge the customer for travel for this campaign per NHTSA, contact service if you have any questions.**

Note: Future notices to dealers and owners are dependent upon the receipt of warranty claims.

OWNER NOTIFICATION

Sample letter: Included at the end of this bulletin is a sample letter which will be sent by Vermeer Corporation on behalf of Vermeer MV Solutions directly to the owners on or about October 27, 2022, via USPS certified/registered mail. After receiving VMV000028 from Vermeer MV Solutions, you must **contact your affected customer(s) immediately** and schedule a mutually acceptable time to upgrade their machine(s).
