## SAFETY RECALL CAMPAIGN

# SUBJECT: TRAILER TOW HITCH HARNESS INSPECTION (SC249B)

This bulletin provides information to inspect certain 2016-2023MY Kia vehicles regardless of whether or not equipped with a Genuine Kia Tow Hitch harness accessory (Refer to page 2). A fire may occur in the area of the tow hitch harness module while driving or while the vehicle is parked with the ignition OFF. Foreign materials and moisture contamination on the tow hitch harness module printed circuit board (PCB) may result in an electrical short circuit, increasing the risk of a tow hitch harness module fire. Since a remedy is not yet available, in the interim, dealers can follow the procedure outlined in this publication to inspect SC249B vehicles for an installed trailer tow hitch harness and if the vehicle is NOT equipped, the SC249B safety recall can be closed. Once the repair remedy becomes available, dealers are to inspect the affected vehicle to address the fire risk. This Technical Service Bulletin (TSB) will be updated with the recall remedy as soon as it is available so the recall can be completed on vehicles equipped with a Genuine Kia Tow Hitch harness accessory (SC249A & SC249B). Before conducting the procedure, verify that the vehicle is included in the list of affected VINs.



### **Inspection Procedure:**



VINs under SC249A (PIO) No remedy available, pending further evaluation.

- 1. Inspect the rear of the vehicle (SC249B VINs).
  - Vehicle is **not equipped** with a tow hitch harness. No further action is required.



Vehicle is equipped with a 'Genuine Kia'
 4-Pin tow hitch harness.

Wait for the recall repair remedy. This Safety Recall cannot be closed at this time.
