Description of the Defect : The rear bunkrooms' flip-up bunks supporting angle brackets may not have been installed completely into backers in the walls.

FMVSS 1 : NR

Description of the Safety Risk : If the bunk angle support bracket fails to support the bunk, the bunk may fail, allowing a user to fall from the bunk which may potentially lead to personal injury.

Description of the Cause : The angle bracket that supports the bunk in the "use" position may not have been securely installed into a backer in the wall.

On October 5, 2022, during a routine PDI/Corporate Standards inspection it was found that the angle brackets for the bunk ladder may not be installed completely into the backers in the wall. On that same day, the manufacturing plant addressed all of the AVT32BHS in their possession.

On October 6, 2022, Forest Rivers Office of Corporate Compliance was able to identify all vehicles involved.

On October 7, 2022, Forest Rivers Corporate Recall Committee voted to recall
