9/16/2022 - Plant 6 runs out of 54 X 34 egress windows. Purchasing shows sufficient quantities were ordered and delivered.

9/19/2022 - Inventory in the shipping yard is put on hold when units are found without egress windows.

9/23/2022 - All inventory in the yard are inspected and necessary corrections made. All units in the shipping yard are made compliant.

9/26/2022 - Inventory records searched to determine if additional units could be affected.

10/3/2022 - Purchasing determines additional units could be at risk.

10/4/2022 - Potential population is established.

10/7/2022 - A safety committee meeting is held and votes to issue a recall for inspection and necessary corrections.

### Description of Remedy :

Description of Remedy Program : Inspect and install egress window as necessary. All reimbursements will follow the general reimbursement policy on file.

How Remedy Component Differs from Recalled Component : The presence of an egress window in the living room slide out.

Identify How/When Recall Condition was Corrected in Production : Proper egress window placement through additional training and QC verification.
