**Reason for
this recall**

The vehicles subject to this recall were built without a secondary egress window in the living room slide out. This could hinder your evacuation of the vehicle during an emergency situation which could result in an increased risk of personal injury or death. This repair will be done at no cost to you.

**What we
will do**

The remedy is to inspect your vehicle and replace the window if necessary. The repair should take approximately one hour to complete. This repair will be done at no cost to you.

**What we need
you to do**

You should contact your selling dealer immediately to schedule a service appointment to have the defect repaired in your vehicle.
