FILLER FUEL NECK INSPECTION

 Locate fuel cap on ODS rear of coach (Figure 1 & 2).
There will be one on Seismic FW and two on Seismic Luxury FW.





 Check to make sure fuel cap seats properly to the fuel neck. If bad (Figure 3), the fuel neck will need changed. (Figure 4)





FILLER FUEL NECK REPAIR INSTRUCTIONS

3. Begin by removing the two fuel neck screws using a #2 square drive. (Figure 5 & 6)






- 4. Loosen the hose clamps on the back side of the fuel neck using a 5/16" socket or nut driver. (Figure 7)
- 5. Remove hoses from existing fuel neck and replace with new one. Test fit the cap on the new fuel neck to make sure it seats properly before installing it. (Figure 8)
- 6. Refasten the hose clamps on new fuel neck. (Figure 9)
- 7. Align fuel neck so that existing pre-drilled



8. Reattach fuel cap with second screw and twist on cap until it clicks. (Figure 11)
