## IMPORTANT SAFETY RECALL Owner Notification

This notice applies to your vehicle, VIN # 1HD1ACL15NB [REDACTED]

Dear Harley-Davidson® Motorcycle Owner:

This notice is sent to you in accordance with the National Traffic and Motor Vehicle Safety Act.

Harley-Davidson Motor Company, Inc. has decided that certain model year 2019 – 2022 Trike/CVO Trike motorcycles (see table below) and certain model year 2020 – 2022 Touring/CVO Touring motorcycles (see table below) fail to conform to Federal Motor Vehicle Safety Standard No. 108, *Lamps, reflective devices, and associated equipment*. We are notifying you because our records indicate that you may own one of these motorcycles.

### What is the Issue?

The brake light(s) may illuminate regardless of whether the rider applies the brakes. If the brake light(s) remain on, this may confuse other drivers, and increase the risk of a crash.

### What Should You Do?

Please contact your authorized Harley-Davidson motorcycle dealer and arrange an appointment to have your motorcycle repaired.

- For Touring and CVO Touring models, the remedy involves a software update only. This update should take less than 30 minutes.
- For Trike and CVO Trike models, the remedy involves a software update and installation of a new brake switch. The recall kits are expected to begin shipping to authorized Harley-Davidson dealers in early December 2022. This repair should take approximately 2 hours.

To schedule an appointment to have your motorcycle repaired, please contact your Harley-Davidson dealer. The repair will be performed at no cost to you. Due to scheduling, the dealer may require your motorcycle for a longer period. Once the service has been completed, your dealer will ask you to sign a recall claim. If you have previously paid to have this condition addressed, you may be eligible for reimbursement. For more information, please contact us at the number below.

If you have sold your motorcycle and have an address for the current owner, it is important that you forward this notice to the new owner. Alternatively, you may contact us at the Harley- Davidson phone numbers listed below and provide us with the new contact information so that we may notify the new owner of this recall. Also, federal law requires that any vehicle lessor receiving this recall notice must forward a copy of this notice to the lessee within ten (10) days.
