In or around late June / early July of 2022, two customer complaints, including one VOQ, related to LP line contacting a rear tire were reported to Winnebago. Subsequently an investigation was opened. During the course of the investigation, Winnebago Industries identified 22 incidents where the LP line was found to be in contact with the rear tire, occurring between November 2020 and October 2022. On 10-12-22 Safety Committee met and determined this was a recall. On 10-14-22 Recall committee met. On 10-21-22 submitted 573 notice on NHTSA portal.
