# IMPORTANT SAFETY RECALL NHTSA Recall No. 22V804

This notice applies to your vehicle, VIN

Dear Lamborghini Owner or Lessee,

This notice is sent to you in accordance with the National Traffic and Motor Vehicle Safety Act. Automobili Lamborghini S.p.A. has decided that certain Model Year 2022 Urus vehicles fail to conform to Federal Motor Vehicle Safety Standard No. 111, "Rear Visibility." Our records indicate that you are the owner of a vehicle in this recall.

#### What is the issue?

The infotainment main unit in the center console may become damaged, which can cause the rear-view camera image to be inoperative. An inoperative camera image reduces the driver's rear visibility, increasing the risk of a crash.

For all the reasons set forth above, it is therefore necessary to repair these vehicles. If you are not the only driver of this vehicle, please advise all other drivers and passengers of this important information.

#### What Do You Need to Do?

You can still drive your car, however, please contact your preferred authorized Lamborghini dealer immediately to schedule an appointment to have this important repair performed, free of charge.

#### What will Lamborghini do?

We will replace the infotainment main unit, free of charge. Normally, the repair work will take approximately 4 hours. We apologize for any inconvenience this recall may cause.

Please bring this letter and your Service Booklet with you when you visit the dealer, so that the dealer can make all necessary entries.

Lamborghini will not offer a reimbursement plan for this campaign as all involved vehicles are new and would be covered under the manufacturer's warranty program.
