## **IMPORTANT SAFETY RECALL**

NHTSA Recall No. 22V848

#### This notice applies to your vehicle, VIN ZHWUA9ZD

Dear Lamborghini Owner or Lessee,

This notice is sent to you in accordance with the National Traffic and Motor Vehicle Safety Act. Automobili Lamborghini S.p.A. has decided that a defect, which relates to motor vehicle safety, exists in certain Model Year 2022 Countach vehicles. Our records indicate that you are the owner of a vehicle in this recall.

#### What is the issue?

Due to a supplier error, the rear bonnet glass panels could fully detach from the vehicle, creating a road hazard and increasing the safety-risk of a crash for following traffic.

For all the reasons set forth above, it is therefore necessary to repair these vehicles. If you are not the only driver of this vehicle, please advise all other drivers and passengers of this important information.

#### What Do You Need to Do?

You can still drive your car, however, please contact your preferred authorized Lamborghini dealer immediately to schedule an appointment to have this important repair performed, free of charge.

#### What will Lamborghini do?

We will inspect the vehicles for appropriate bonding of the glass panels and, if necessary, they will be replaced free of charge. The inspection will take approximately 1 (one) hour. In case replacement of the glass panel is necessary it will take approximately 8 (eight) hours. We applogize for any inconvenience this recall may cause.

Please bring this letter and your Service Booklet with you when you visit the dealer, so that the dealer can make all necessary entries.

Lamborghini will not offer a reimbursement plan for this campaign as all involved vehicles are new and would be covered under the manufacturer's warranty program.
