Description of the Defect : Exterior corners of cabinet door handles are sharp which can cause personal injury in the event forceful contact is made.

FMVSS 1 : NR

FMVSS 2 : NR

Description of the Safety Risk : The sharp corners on the cabinet door handles can scrape or cut occupants arms or legs when inadvertently contacted.

Description of the Cause : Extruded then cut handles have square corners that are sharp.

Chronology :

In late 2021, Grand Design investigated reports of a personal injury related to sharp cabinet drawer handles. A subsequent recall was conducted in early 2022 to replace the handles. In late September 2022, it was identified that there may be similar injury claims on some Winnebago Towable products and a subsequent investigation was initiated. Upon investigation, it was determined that for a period of time, Winnebago Towables used a similar style cabinet drawer handle. The part numbers for the drawer handles were different, however the design was similar. After determining the scope of the products built with suspect handles and reviewing the nature of the relevant claims, the product safety committee met to review the findings. On 11/21/22 the Product Safety Committee decided that the issue presented a risk to motor vehicle safety and therefore decided a recall was necessary.

There are 17 known injuries (cuts/scrapes to arms and legs) with the first identified case occurring in October 2020.

Description of Remedy :

Description of Remedy Program : New door handles to be sent to dealerships to replace.

Reimbursement request will fall under the general reimbursement plan on file with NHTSA.

How Remedy Component Differs from Recalled Component : New door handle has a rounded front with no sharp corners on the exposed surface.

Identify How/When Recall Condition was Corrected in Production : Handles were changed to a different style through model year product changeovers.
