installed during the manufacturing process.

On September 7, 2022: Mazda detected headlamps with horizontal aiming prevention caps missing from part supplier. Mazda began to investigate.

On the September 12, 2022: Mazda identified the root cause and conducted a mass production change. Middle of November 2022: Mazda investigated potentially affected models and population with this defect. November 24, 2022; Mazda held a Quality Audit Committee meeting to review all available information to date and decided to conduct a recall covering the subject vehicles in the U.S. and U.S. territories. No accidents, injuries or deaths have been reported because of this defect.

Description of Remedy:

Description of Remedy Program: Owners will be notified by mail and instructed to take their vehicle to a Mazda dealer.

> Dealers will install a headlamp horizontal aim adjustment prevention cap on each headlamp. There will be no charge for this service to vehicle owners. As subject models are covered under new vehicle warranty, a reimbursement program will not be offered.
