axles installed or distributed by East Mfg contained a defect. Smart-Steer 2.0 axles with 702887 bolt on steer are built from October 13, 2017 to October 30, 2022. Under certain heavy loading conditions the steer arm attached to the knuckle can potentially shear. If this happens the upper section of the sheared steer arm will remain attached to the knuckle by the mounting bolts and the lower section of the steer arm will remain attached to the tie-rod assembly but potentially drag along the ground.
