Problem Description:

Lightning eMotors Inc. (Lightning eMotors) is recalling certain 2021-2022 FE4-129 vehicles equipped with Romeo Power battery packs. The high voltage battery may lose traction power while driving or fail to start.

Consequence:

A sudden loss of traction power while driving increases the risk of a crash.

Remedy

The remedy is currently under development. Owner notification letters are expected to be mailed February 14, 2023. Owners may contact Lightning eMotors customer service at 1-970-744-4926 or 1-800-223-0740. Lightning eMotors number for this recall is LeM Recall 2022-002.

Also, copies of all notices, bulletins, dealer notifications, and other communications that relate to this recall, including a copy of the final owner notification letter and any subsequent owner follow-up notification letter(s), are required to be submitted to this office no later than 5 days after they are originally sent (if they are sent to more than one manufacturer, distributor, dealer, or purchaser/owner).

Please be reminded that under 49 U.S.C. § 30112(a)(3), it is illegal for a manufacturer, to sell, offer for sale, import, or introduce or deliver into interstate commerce, a motor vehicle or item of motor vehicle equipment that contains a safety defect once the manufacturer has notified NHTSA about that safety defect. This prohibition does not apply once the motor vehicle or motor vehicle equipment has been remedied according to the manufacturer's instructions.

As stated in Part 573.7, submission of the first of eight consecutive quarterly status reports is required within one month after the close of the calendar quarter in which notification to purchasers occurs. Therefore, the first quarterly report will be due on, or before, 30 days after the close of the calendar quarter.
