Mercedes-Benz AG ("MBAG"), the manufacturer of Mercedes-Benz vehicles, has decided that a defect which relates to motor vehicle safety exists in certain model year ("MY") 2021–2022 GLS-Class and GLE-Class vehicles. Our records indicate that your vehicle is included in the affected population.

What is the issue?



The steering coupling locking screws may loosen and possibly detach from the steering gear, resulting in a loss of steering control. A loss of steering control can increase the risk of a crash. Before the issue occurs, the driver may be made aware of the issue by resulting noises when driving on uneven roads.

What will your Mercedes-Benz Dealership do?



An authorized Mercedes-Benz dealership will replace the steering coupling locking screws on the affected vehicles. This vehicle repair will be provided at no cost to you. While the minimum repair time can be less than 1 hour, your dealership can provide you with a better estimate of the overall time for this recall repair. As a matter of normal service process, an authorized Mercedes-Benz dealer will also check for other repair measures which might be applicable to your vehicle and this may increase the required working time. You will not be charged for other services or repairs unless so requested.
