Dear Valued Fleetwood Customer:

This notice is sent to you in accordance with the requirements of the National Traffic and Motor Vehicle Safety Act. This is to inform you that your vehicle may contain a defect that could affect the safety of a person.

REV Recreation Group Inc. has decided that a safety defect relating to motor vehicle safety exists on products within model year 2021-2023 Fleetwood brand gasoline and diesel motorhomes.

WHAT IS THE PROBLEM?

On motorhomes affected by this recall campaign, the Manchester Propane Tank may have a service valve with incorrect thread depth on the POL outlet, which could result in a leak of propane.

Identify any warning which can precede or occur: A leak in an enclosed area in the presence of an ignition source could lead to a fire, and in some circumstances, tank ruptures. Leaking valves may be detected by smell, sound, or loss of propane.

WHAT SHOULD YOU DO?

Please make certain your motorhome is immediately inspected and repaired by contacting an **authorized REV Recreation Group servicing dealer**. REV Recreation Group recommends that you should shut off the service valve (main shutoff) on the propane tank until your motorhome is inspected.

WHAT WILL REV RECREATION GROUP DO?

With your continued satisfaction in mind, it is our intention to have these repairs made at your convenience with as little disruption as possible. Effective immediately, REV RV dealers have been supplied with all the information needed to enable them to inspect, test and if needed replace the service valve.

The repair should take approximately one (1) hour to complete; however, because of service scheduling times, your dealer may need the vehicle for a longer period of time. This service will be performed for you free of charge.

When you deliver your motorhome for repairs, your dealer will complete a **Repair Order**. Upon completion of the repair, please sign the **Repair Order** and fill out the enclosed self-addressed **Vehicle/Owner Information Update Card** and return it to REV Recreation Group.

If you have changed your address or sold the motorhome, please take a moment to provide the name and address of the person or dealership you sold it to on the enclosed **Vehicle/Owner Information Update Card** and return it to REV Recreation Group. This will allow us to update our records and if necessary, notify the new owner using the information you provide.
