09/22 Comoto were notified that the sizes S, M, & XL helmets manufactured 2021 that were tested at ACT Lab USA were found to be noncompliant with FMVSS 218. 10/22 Comoto also sent size L for testing and were advised that this also failed. Comoto was extremely surprised by the noncompliance because the model had PPass results from both ACT Labs China December, 202 and ACT Labs USA in May 2022. After reviewing the tests, Comoto decided to voluntarily initiate this recall.
