Description of the Defect : Per WARN Recall Notice 22E-101 ..After investigating field reports of inadvertent activation, Warn determined that getting the remote control wet could result in water ingress and corrosion inside the remote control. This condition could lead to inadvertent activation. It was determined that this condition only affects remote controls with wireless capability that are not water proof.

Description of the Safety Risk : Per WARN Recall Notice 22E-101 ..Personal injury if winch operates unexpectedly. No injuries have been reported associated with any product failures. No significant property damage other than the winch system, winch mounting brackets and front bumpers have been reported as a result of corrosionrelated issues.

Description of Remedy :

Description of Remedy Program : Contacting owners of the effected units. Collecting contact data and working with WARN to reimburse owners per recall report 22E-101

How Remedy Component Differs from Recalled Component : per recall report 22E-101 .. Removing the battery pack from the current remote control disables the wireless function controlling the winch, significantly mitigating the hazard. The remote remains fully usable in the corded configuration when physically plugged into the winch. Unplugging the remote from the winch when not in use eliminates the hazard. The new corded-only remote that will be used in reworked existing unsold inventory, will have a new switch face that is visually different from the

current remote. It will not have wireless control functions, including wireless indicator light and mode switch. The internal circuit board will be fully conformal coated and use sealed switches.
A new wireless/corded handheld remote is being designed for all new production winches
