This letter serves to acknowledge RevHD's notification to the National Highway Traffic Safety Administration (NHTSA) of a safety recall which will be conducted pursuant to Federal law for the product(s) listed below. Problem Description:

RevHD is recalling certain oil and PSI oil Hubcaps with part number RHO-T03&-S01&-T04, and sizes 6" to 8". The lens on the hubcaps may become loose, causing lubricant to leak out of the wheel end.

Consequence:

Loss of lubricant in the wheel end can overheat the wheel bearings, increasing the risk of a fire. In addition, a loose hubcap lens can detach and increase the risk of a crash.

Remedy:

RevHD will refund owners, or replace the hubcaps, free of charge. Distributors are expected to be notified in August 2023. Owners may contact RevHD customer service at 1-615-752-8628.

We have received RevHD's proposed owner notification letter and it is currently under review. You will be notified of any changes or concerns once our review is complete.



Please be reminded of the following requirements:

Copies of all notices, bulletins, dealer notifications, and other communications that relate to this recall, including a copy of the final owner notification letter and any subsequent owner follow-up notification letter(s), are required to be submitted to this office no later than 5 days after they are originally sent (if they are sent to more than one manufacturer, distributor, dealer, or purchaser/owner).

Please be reminded that under 49 U.S.C. § 30112(a)(3), it is illegal for a manufacturer, to sell, offer for sale, import, or introduce or deliver into interstate commerce, a motor vehicle or item of motor vehicle equipment that contains a safety defect once the manufacturer has notified NHTSA about that safety defect. This prohibition does not apply once the motor vehicle or motor vehicle equipment has been remedied according to the manufacturer's instructions.

As stated in 49 U.S.C. § 30118(f), submission of eight consecutive quarterly reports followed by three annual reports is required. As described in 573.7, submission of the first of eight consecutive quarterly status reports is required within one month after the close of the calendar quarter in which notification to purchasers occurs. Therefore, the first quarterly report will be due on, or before, 30 days after the close of the calendar quarter. The first of three consecutive annual status reports will be due on, or before, 1 year after the eighth quarterly report was submitted.
