Description of the Defect : The resin emblem on the driver's airbag module cover in affected vehicles may have reduced durability due to potential Tier 2 supplier production process variation. In this condition, the posts of the emblem may develop cracks over time, and the emblem and retainer components could detach in the event of an airbag deployment.

Description of Remedy Program : Dealers will replace the driver's airbag cover. Nissan is working with the supplier on final parts timing targeting late Fall/early Winter 2023 for availability. When the repair is ready, customers will receive a final invitation to repair letter. All inspections and repairs will be performed free of charge for parts and labor.

Nissan will include a statement in the Part 577 owner notification concerning reimbursement for the cost of obtaining a pre-notification remedy for a subject vehicle that is no longer under warranty at time of repair.
