#### **Chronology**:

1/20/2023 - A VOQ was provided to TMC regarding an awning extending while driving.
1/25/2023 - A VOQ was provided to TMC regarding another unit's awning extending while driving.
1/25/2023 - Customer service rep had a customer report the same issue on their Scope 18M.
2/1/2023 - A FRC analysis was performed for all units with the affected component installed. Two additional claims were found containing similar complaints.
2/8/2023 - TMC safety committee met and discussed this issue and voted to issue a recall.
2/14/2023 - TMC met with CareFree to further discuss the issue causing the awnings to drift and determine a possible solution.
3/3/2023 - TMC met with Carefree to go over the recall remedy that will be used in repairing the units.
3/10/2023 - TMC received serial number data from awnings to help determine the scope of units involved.
3/13/2023 - The repair for the awning has been created and the part is being made for the remedy.
3/20/2023 - A final scope list has been completed and an amendment will be filed.
