Description of Remedy Program :	Nissan is preparing the remedy for this issue. In the interim, registered owners will be notified. In that notification, owners will be instructed to avoid attaching accessories to the key fob and to use the key in the non- folding orientation until the remedy is available. In addition, dealers and rental fleets will be instructed on an interim remedy to insert a fastener into the key slot that will prevent the key from folding. When remedy parts are available, dealers will insert a spacer into the key slot of the customer's key fob that will not allow the key to collapse. Nissan will include a statement in the Part 577 owner notification concerning reimbursement for the cost of obtaining a pre-notification remedy since the subject vehicles are no longer under warranty.
