This notice is sent to you in accordance with the National Traffic and Motor Vehicle Safety Act.

Ferrari has decided that a defect which relates to motor vehicle safety exists in certain Model Year 2021 - 2023 Ferrari SF90 vehicles. The vehicles involved are equipped with an incorrect passenger seat. As a result, in case of an accident, the deployment of a passenger side airbag could possibly impact a child seat, thereby potentially causing abnormal body acceleration, which may lead to injuries and/or death. We want to assure you that your safety is our priority, and we are committed to correcting this condition in your vehicle if it exists.

Our records show that you are the owner of a vehicle affected by this recall.

IMPORTANT

THE REPLACEMENT PART IS NOW AVAILABLE; PLEASE CONTACT YOUR AUTHORIZED FERRARI DEALER TO SCHEDULE YOUR REPAIR. Ferrari will repair your vehicle free of charge. The repair consists of replacing the vehicle's M size passenger seat with an XL size passenger seat. The time needed for the repair is estimated to be approximately 30 minutes. In the meantime, you should not use and/or install a child seat in your vehicle.
