

## IMPORTANT SAFETY RECALL

This notice applies to your vehicle (VIN:

This notice is sent to you in accordance with the National Traffic and Motor Vehicle Safety Act.

Ferrari has decided that a defect which relates to motor vehicle safety exists in certain Model Year 2021 - 2023 Ferrari SF90 vehicles. The vehicles involved are equipped with an incorrect passenger seat. As a result, in case of an accident, the deployment of a passenger side airbag could possibly impact a child seat, thereby potentially causing abnormal body acceleration, which may lead to injuries and/or death. We want to assure you that your safety is our priority, and we are committed to correcting this condition in your vehicle if it exists.

Our records show that you are the owner of a vehicle affected by this recall.

## **IMPORTANT**

Ferrari will repair your vehicle free of charge. The repair consists of replacing the vehicle's M size passenger seat with an XL size passenger seat. **The replacement part is not yet available**; we will contact you again when the replacement part is in dealer stock. The time needed for the repair is estimated to be approximately 30 minutes. **In the meantime, you should not use and/or install a child seat in your vehicle**.

If you have previously paid for repair to your vehicle for this specific condition prior to receiving this letter, send your original receipts and/or other adequate proof of payment to the following address for reimbursement: Ferrari North America, Inc., 250 Sylvan Ave., Englewood Cliffs, NJ 07632 Attention: Warranty Department. Once we receive and verify the required documents, reimbursement will be sent to you within 60 days.

<u>For vehicles registered in California</u>: The California Department of Motor Vehicles, in conjunction with California Air Resources Board, requires the completion of emission recall repairs prior to vehicle registration renewal, per the Registration Renewal/Recall Tie-in Program. Your authorized Ferrari dealer will provide you with a Proof of Correction Certificate after the recall repair has been performed.
