## **Problem Description:**

Daimler Trucks North America, LLC (DTNA) is recalling certain 2023-2024 Thomas Built SAF-T-LINER C2, SAF-T-LINER Jouley, 2023 SAF-T-LINER EFX Chassis, HDX Chassis, and SAF-T-LINER MVP-EF school buses. The tie rod may be missing a fastener, allowing the steer arm to detach.

#### **Consequence:**

A detached steering arm can result in a sudden loss of steering control, increasing the risk of a crash.

#### Remedy

The remedy is currently under development. Owner notification letters are expected to be mailed June 4, 2023. Owners may contact DTNA customer service at 1-800-547-0712. DTNA's number for this recall is FL970.

Also, copies of all notices, bulletins, dealer notifications, and other communications that relate to this recall, including a copy of the final owner notification letter and any subsequent owner follow-up notification letter(s), are required to be submitted to this office no later than 5 days after they are originally sent (if they are sent to more than one manufacturer, distributor, dealer, or purchaser/owner).

Please be reminded that under 49 U.S.C. § 30112(a)(3), it is illegal for a manufacturer, to sell, offer for sale, import, or introduce or deliver into interstate commerce, a motor vehicle or item of motor vehicle equipment that contains a safety defect once the manufacturer has notified NHTSA about that safety defect. This prohibition does not apply once the motor vehicle or motor vehicle equipment has been remedied according to the manufacturer's instructions.

As stated in 49 U.S.C. § 30118(f), submission of eight consecutive quarterly reports followed by three annual reports is required. As described in 573.7, submission of the first of eight consecutive quarterly status reports is required within one month after the close of the calendar quarter in which notification to purchasers occurs. Therefore, the first quarterly report will be due on, or before, 30 days after the close of the calendar quarter. The first of three consecutive annual status reports will be due on, or before, 1 year after the eighth quarterly report was submitted.
