4/21/2023 - TMC's safety committee met and voted to issue a recall based on the information provided by Cummins. Population is still being determined by IT department and the 573 will be updated once this information has been determined.

4/28/2023 – IT provided population scope and amendments have been made to include all models involved as well as file with TC for Canadian units involved.
