Description of the Defect : Certain Della Terra & Silver Lake Travel Trailers' Federal Placard may have been erroneously printed with an inaccurate dry weight and cargo carrying capacity.

FMVSS 1 : NR

Description of the Safety Risk : The vehicle may have an inaccurate cargo carrying capacity. This condition may lead to an operator overloading the vehicle, possibly leading to a crash increasing the risk of injury.

Description of the Cause : Debris under the scale pads did not let the vehicle fully depress the pad which did not correctly weight the vehicles.

On April 14, 2023, Forest River's Office of Corporate Compliance ("OCC") was contacted by the manufacturing plant concerning the scale weights may be printing inaccurately. OCC opened an investigation.

On April 17, 2023, and April 18, 2023, OCC reviewed the scale weight report of vehicles manufactured within the scope time frame versus vehicles manufactured prior to the scope time frame to a certain if there was any significant difference.

On April 21, 2023, OCC presented finding to the Corporate Recall Committee which voted to recall the vehicles.

**Description of Remedy :**

Description of Remedy Program : Forest River will provide all parts and labor free of charge to Consumers and Dealers. An authorized Forest River dealer will need to perform the remedy. The Federal Placard will be replaced.
