Dear Valued Customer:

This notice is sent to you in accordance with the National Traffic and Motor Vehicle Safety Act.

Mercedes-Benz AG ("MBAG"), the manufacturer of Mercedes-Benz Sprinter vans and the Jayco Motorized Division, have decided that a defect which relates to motor vehicle safety exists in certain Model Year ("MY") 2019-2022 Mercedes-Benz Sprinter vehicles. This includes certain model year ("MY") 2020-2021 Jayco Melbourne and Melbourne Prestige Class C motorhomes. Our records indicate that your vehicle is included in the affected population of vehicles.

Reason for this recall

On certain Sprinter vehicles, the instrument cluster might fail to display upon vehicle start up. A blank instrument cluster will not show critical information such as speed, the fuel gauge, warning lights and warning messages, as well as acoustic warnings, increasing the risk of a crash.

Recall Remedy An authorized Mercedes-Benz Sprinter dealer will update the instrument cluster software on the affected vehicles. This could take approximately 30 minutes. This service will be provided free of charge.

What we need you to do If you had this Mercedes-Benz recall completed disregard this notice. If this is a leased vehicle and the lessor and registered owner receive this notice, please forward this information by first class mail to the lessee within 10 business days to comply with Federal Regulations.

If you had this repair completed prior to receipt of this recall notice, you may be eligible to receive reimbursement for the cost of obtaining a pre-notification remedy of the problem associated with this recall.
