May 1, 2023: Autocar personnel identified a loose fuel tank strap and began investigation. May 1 through May 17, 2023, Investigation continued, the installation instructions and tooling used during assembly were updated. May 30, 2023, the assembly process was audited, and the assembly error was determined. June 1, 2023, through June 12, 2023, Autocar personnel were retrained, all in-house units were quarantined and checked or reworked and a clean point established for production. June 15, 2023, all relevant information was presented to Autocar management team and out of an abundance of caution Autocar decided to perform a voluntary safety recall for all affected units. We have no known complaints or claims.

### **Description of Remedy:**

Description of Remedy Program: Autocar will voluntarily initiate an owner notification and recall of all affected vehicles. Autocar will distribute to owners of affected vehicles an Owner Notification Letter, which will describe the defect and provide instructions for scheduling the inspection/repair of the vehicle at no cost to the vehicle's owner.
