This letter serves to acknowledge Yamaha Motor Corporation, USA's notification to the National Highway Traffic Safety Administration (NHTSA) of a safety recall which will be conducted pursuant to Federal law for the product(s) listed below. ### **Problem Description:**

Yamaha Motor Corporation, USA (Yamaha) is recalling certain 2022 Tenere 700 (XTZ7N) motorcycles. The front brake calipers may have been assembled with bolts that have an incorrect thread length, which can damage the mounting hole threads in the brake caliper.

## **Consequence:**

Damaged brake calipers can detach and cause a loss of braking ability, increasing the risk of a crash.

## Remedy:

Owners should not operate their motorcycle, other than take it to a dealer, until the remedy is performed. Dealers will inspect the length of the front brake caliper bolts and replace them, if necessary. If the caliper mounting-hole threads are damaged, the caliper will be replaced. Repairs will be performed free of charge. Owner notification letters are expected to be mailed July 20, 2023. Owners may contact Yamaha's customer service at 1-800-962-7926. Copies of all notices, bulletins, dealer notifications, and other communications that relate to this recall, including a copy of the final owner notification letter and any subsequent owner follow-up notification letter(s), are required to be submitted to this office no later than 5 days after they are originally sent (if they are sent to more than one manufacturer, distributor, dealer, or purchaser/owner).

Please be reminded that under 49 U.S.C. § 30112(a)(3), it is illegal for a manufacturer, to sell, offer for sale, import, or introduce or deliver into interstate commerce, a motor vehicle or item of motor vehicle equipment that contains a safety defect once the manufacturer has notified NHTSA about that safety defect. This prohibition does not apply once the motor vehicle or motor vehicle equipment has been remedied according to the manufacturer's instructions.

As stated in 49 U.S.C. § 30118(f), submission of eight consecutive quarterly reports followed by three annual reports is required. As described in 573.7, submission of the first of eight consecutive quarterly status reports is required within one month after the close of the calendar quarter in which notification to purchasers occurs. Therefore, the first quarterly report will be due on, or before, 30 days after the close of the calendar quarter. The first of three consecutive annual status reports will be due on, or before, 1 year after the eighth quarterly report was submitted.
