April 11, 2023 Jayco Inc. received notice of DTNA Recall FL969/NHTSA Recall 23V-237. April 17, 2023 Jayco's Warranty Incident Review Committee (WIRC) reviewed the incident and elevated it to the Corrective Preventive Action Committee (CPAC). On April 19, 2023 CPAC decided to elevate the incident to the Safety Steering Committee (SSC). On July 10, 2023 SSC voted to proceed with a pass through chassis recall.

Description of Remedy:

Description of Remedy Program: Inspect the date code on the windshield wiper arms and replace as needed.

Repairs will be performed free of charge by Daimler Truck North America authorized service facilities. Details of the reimbursement plan will be included in the owner's notification letter. Owners are directed to seek

reimbursement through authorized dealers.
