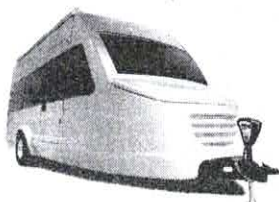

IMPORTANT SAFETY RECALL

This notice applies to your vehicle, (VIN)
NHTSA Recall No. 23V530
Cummins Campaign #PG5215

Dear Customer,

This notice is sent to you in accordance with the National Traffic and Motor Vehicle Safety Act.

Chinook Motor Coach has decided that a defect, which relates to motor vehicle safety, exists in certain 2020-2024 Chinook Bayside vehicles.

WHY DOES MY VEHICLE NEED REPAIRS?

Cummins, Inc. conducted a recall for certain Onan QG 2800i and QG2800i EVAP generators. Chinook RV records indicate that your Chinook Bayside contains one of these recalled generators.

The fuel hose between the inline fuel filter and the Injection Pump Module may have inadequate clamp force, possibly resulting in a gasoline leak. A gasoline leak may increase the risk of fire in the presence of an ignition source.

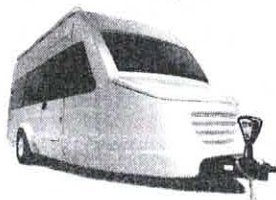
WHAT WILL YOUR DEALER DO?

Your authorized Cummins dealer will inspect the fuel hose and, if necessary, replace the fuel hose, free of charge. The repair should take approximately 1.7 hours to complete. However, due to scheduling, your dealer may require your vehicle for longer. Your dealer should be able to provide a more accurate repair estimate.

WHAT SHOULD YOU DO?
