In this case, the headlamps might be adjusted slightly too high and might exceed the range specified by FMVSS 108 S.10 by approximately 0.05%. A headlamp adjustment that is outside o specifications has the potential to create glare for oncoming traffic, which may increase the risk of a crash.		
What We're Doing		MBUSA will conduct a voluntary recall. An authorized Mercedes-Benz dealer will check the headlamp adjustment on the affected vehicles and correct it, if necessary.
